This report is for the calendar year January to December 2011 inclusive.

2011 has been an exceptionally busy year for the Urban Bushland Council. Our major focus has been the *Celebration of Biodiversity* project (one component of which commenced in 2010) generously funded by Lotterywest. The project had three components: the presentation of two symposia, production of new promotional materials, and the website project. Funding enabled employment of Amrit Kendrick as project officer for the first two, and John Baas as Web Manager. We wish to acknowledge the incredible amount of work done by the volunteer steering groups and managers of each component, as well as the project officers.

The web project was the major component and we now have a modern interactive website which was launched on 3rd August at the WA Herbarium. The Banksia Woodland symposium was an outstanding success, attracting a full house including many local government and state agency people alongside private consultants and community folk. We published printed proceedings of both symposia. The project has certainly boosted the public profile and credibility of the UBC and our precious urban bushland. And the new website is attracting more people to our cause and is generating more work for us.

Website project

The finished product can be found at <u>www.bushlandperth.org.au</u>. At launch on 3 August 2011, it comprised 110 pages grouped into major themes that included Urban Bushland; Groups; Activities; Events; Resources; Membership and Gallery. From the Home Page visitors can subscribe to the e-Newsletter, apply to join UBC as a Group or as a Supporter or donate to UBC.

Groups are at the heart of the Urban Bushland Council. At launch, 56 Group pages had been created. This included twenty 'full' individual Group pages; with the remaining Groups having either simple pages with contact details or hyperlinks to their own or to third party linked sites. Very few Groups indicated that they did not wish to be represented.

Google Analytics shows a consistent increase in visitor numbers to the website and we are seeing people apply to join as Groups, Supporters and volunteers through the website. The use of the e-Newsletter function has increased our subscriber list to more than 185 email addresses by the end of 2011.

As part of the project, UBC reviewed and refreshed its branding to ensure that its print material complemented the design of the website.

Support to community groups

Providing information and supporting bushland groups underpins all our work. Three editions of the Urban Bush Telegraph were produced, and we sincerely thank all those people who contributed articles and news of their group activities. Special acknowledgement is due to our newsletter editor Renata Zelinova. Raising community awareness of bushland issues and management, and networking amongst groups is always a challenge. Each group is busy concentrating on its local activities. We assisted some high profile campaigns: Roe 8 extension, Monash Avenue bushland adjacent to QEII Medical Centre, Perry Lakes tree removal by Landcorp in the Canaby's roost site, Underwood Ave bushland and adjacent Bedbrook Place bushland, and Nowergup quarry. A summary of the issues and activities we engaged in is shown in the table below.

Engaging with Government

During the year we continued to lobby and engage decision makers by meeting with Ministers and their staff, other politicians from all parties, agency officers especially in DEC and DOP, as well as presenting many written submissions and appeals for planning amendments, clearing permits and environmental assessments. We had just one meeting with the Environment Minister. 'We' includes our Executive Committee members who specialise in these roles: Marg Owen, Cath Cooper, Kevin McLean, M Gray together with many others from Member groups such as Phylis Robertson, Felicity McGeorge, Heidi Hardisty, David Wake. Many

thanks are due to all the members of groups who do this work for the UBC on top of their own submissions and work for their local groups.

Black Cockatoos

Media interest in our endangered black cockatoos developed during the year. Coverage of local issues such as Monash Avenue was extensive in the local press and this helped focus on cockatoos. Local radio has also engaged in cockatoo matters.

The UBC is affiliated with the Cockatoo Coalition which presented a petition to Parliament via the Minister for the Environment; Water Hon W Marmion MLA at a rally on the steps of Parliament House. The *Cockatoos Need You* campaign ran an on-line petition.

Bush Forever

Implementation of Bush Forever was again on our agenda for action during the year as the process has been curbed by the Barnett government. A meeting with the Treasurer Christian Porter MLA seeking support for more MRIT funds did not bear fruit.

A debate (10 August) on Bush Forever was held in the upper house concerning the Motion moved by Hon. A Xamon MLC to legally protect all BF sites and to provide management plans and resources to manage them. The UBC sent a letter to all MPs in both houses seeking their support for the motion. Many community folk were present in the Gallery during debate. Both Labor and the Greens supported the motion but Liberal & Nationals did not, so it was defeated.
